And, furthermore, the undersigned does hereby expressly stipulate and agree, in consideration of the benefits to the undersigned described hereinabove, to indemnify and hold forever harmless the said Fox Township, its governing body, officers, employees, agents, successors and assigns against loss hereinabove, including the reasonable cause of defense thereof and the undersigned hereby waives any and all right of exemption or contribution to which it may be entitled under the laws of this or any other State as against such claim or indemnity.

## FACILITY USE RULES

1. No alcoholic beverages permitted at the Fox Township Community Park.
2. No pets permitted by rental applicant or guests at any facilities.
3. All facilities are TOBACCO FREE.
4. It is understood and agreed that Fox Township assumes no liability in the occupancy and use of Township facilities. The applicant/user of the Township's facilities takes the same "as is" and "where is", without warranty of any kind from the Township or its agent. By executing the Township's Rental Contract, the applicant agrees that the nature of the relationship existing between the Township of Fox and any applicant(s) utilizing the Township's recreational facilities is that of licensor/license rather than invitor/invitee. Further, such applicant agrees that the Township, in granting an applicant a permit hereunder, does not assume responsibility for or incur liability for any injury to person or property caused by an act or omission of such person or persons or any third person or persons.
5. The applicant must represent a responsible organization or family. You are responsible for the conduct of individuals associated with your group.
6. Township facilities may not be used for meetings promoting subversive, sexist, or racist doctrines.
7. Broken or damaged items will be the responsibility of the organization or family using the facility.
8. The organization or family using the facility is responsible for cleaning and returning the facility to the condition in which it was found prior to their event. This includes the pavilion and the surrounding area. All garbage generated from said event must be removed from the premises.
9. Persons signing the "Facility Use Application Permit" form must be on the premises during the entire use of the facility.
10. Absolutely No decorations, signs, pins, taped, nails etc. are permitted on or in the wood columns, ceiling or borders.

### Pavilions:

**Fox Township Resident:** \$75 per day, *if cleaned up and no damages, \$50 will be refunded*

**Non-Fox Township Resident:** \$100 per day, *if cleaned up and no damages, \$50 will be refunded*

### Athletic Fields

*No fees charges to Fox Twp. Little League or Fox Twp. Rec Soccer*

**Tournaments:** \$250 per day with no concession stand  
\$400 per day with concession stand

Baseball Large Field	\$100
Baseball Small Field	\$75
Soccer Large Field	\$100
Soccer Small Field	\$75
Soccer Sinterfire Field	\$100

### SPECIAL RENTAL:

**ECC Boys Soccer Team: \$1200 for the season.** Includes use of Angela Huey Field for regular season games, use of lights when needed, and use of Sinter Fire Field for practices. **ALL OTHER GAMES WILL BE CHARGED THE "PER GAME" FEE AS LISTED ABOVE.**
